2009/2010 Membership Categories

The payment of the initiation fee is not required for these nonvoting membership categories.

Full privilege designated members receive voting rights upon full payment of the initiation fee.

FAMILY GOLF MEMBERSHIP This membership includes husband, wife, significant other and *dependent children. All family members are entitled to unlimited use of all Club facilities including golf, swim and clubhouse.

FAMILY GOLF II (SINGLE GOLFER MEMBERSHIP) This membership is for families with only one golfer. It includes all of the privileges of the Club for the designated golf member, and all of the privileges of the Club, excluding golf privileges to his or her spouse, significant other or *dependent children. Use of the golf course by all family members other than the designated golf member is limited to 4 times per year with payment of the appropriate golf fees. *Dependants may participate in the Junior Golf program.

SINGLE GOLF This membership includes unmarried persons without *dependents. It also includes married persons legally separated from their spouse, by a court order. If *dependent children reside in the household and/or use the Club facilities, a family membership is required. The member is entitled to use all Club facilities: golf, swim, and clubhouse.

SOCIAL MEMBERSHIP This membership includes husband, wife, significant other and *dependent children. This membership may also be held by persons with no *dependents. Entitles family to use the house and swim facilities only. Use of the golf course by all family members is limited to 4 times per year with payment of the appropriate golf fees. *Dependants may participate in the Junior Golf program.

DINING MEMBERSHIP This membership includes husband, wife, significant other and *dependent children. This membership may also be held by persons with no *dependents. All are entitled to use the clubhouse for dining and social events. There are no golf or swim privileges included in this membership.

CORPORATE Yearly dues of \$10,240.00 must be paid in full at time of application. Corporate Memberships are available for two or more individuals within the corporation. Voting privileges do not apply. Contact the business office for more information.

WAITING GOLF/SOCIAL Members may use the swim and clubhouse facilities and have modified golf privileges. This membership is only available when the golf membership category is full.

*Dependent children are defined as a member's unmarried child under age 21 who resides in the members' residence and a member's child under age 23 who is attending college on a full time basis and resides in the members' residence when not in school.

Non-voting- The Initiation fee is waived for this category. No voting or property rights privileges are given. This is a limited offer and will be discontinued by the discretion of the Board of Governors.

2009/2010 Fees

A complete overview of membership fees is included with this application

Initiation Fee: Not Applicable when applying for a non-voting membership. The non-refundable initiation fee is \$3,500 if paid in full at time of application or \$4,000 if paid in five annual installments of \$800.00 each, or \$4200 if paid in 60 monthly payments of \$70.00. Yearly installments are payable at the beginning of each consecutive fiscal year, October 1st.

Dues: Dues are paid by all members based upon their membership category and are billed for our fiscal year, October 1 through September 30. Those paying monthly will be billed in twelve installments in advance of the fiscal year.

Assessment: The assessment fee is \$660.00 per membership annually. Annual assessments are paid by all membership categories except dining and corporate. Assessments charged to members are reserved for the payment of debt service only. The assessment may be paid in full or billed on a monthly basis.

Food Minimum:

A quarterly food minimum that includes non-alcoholic beverage purchases applies to all categories of membership as listed above. Reduced minimums for single members are available. A 17% gratuity and 6% sales tax are added to all applicable food and beverage charges. The gratuity and sales tax do not apply toward your minimum. Quarterly minimum obligations come due on an alpha-cycle, based on the first letter of your last name. The membership is split into three groups for this purpose, with quarters ending on the last day of the following months;

Group #1	A through G	March / June / Sept. / Dec.
Group #2	H through O	April / July / Oct. / Jan.
Group #3	P through Z	May / Aug. / Nov. / Feb.

Members may opt to prepay their food minimum on a bi-annual basis. Members choosing to do so are not subjected to the quarterly cut off schedule.
